 - Signs applied for installation on City or Regional roads will be subject to the approval and fee schedules of the City or Region as applicable.
 - The City reserves the right to terminate this agreement and my TODS signs at any time without compensation.
 - I, personally and on behalf of the organization, release and hold harmless the City for any loss or damage that may result from the installation (or non-installation) of my/the organization's TODS signs.
